- **B.** Public Hearings/Quasi-Judicial Hearings: Any citizen is entitled to speak on items under these Sections at the time these items are heard by the Board.
- 2. **SIGN IN SHEET:** Prior to the start of the Board Meeting, individuals wishing to address the Board should sign in on the sheet located on the conference room table when entering the conference room. If you are not able to do so prior to the start of the meeting, you may still address the Board. The primary purpose of the sign-in sheet is to assist staff with record keeping. Therefore, when you stand to speak, please complete the sign-in sheet if you have not already done so.
- 3. ADDRESSING THE BOARD: At the appropriate time, please stand and state your name and address for the record. All comments must be addressed to the Board as a body and not to individuals. Any person making impertinent or slanderous remarks or who becomes boisterous while addressing the Board, shall be barred by the presiding officer from speaking further, unless permission to continue or again address the Board is granted by a majority vote of the board members present.

Please be advised that if a person decides to appeal any decision made by the Board with respect to any matter considered at this meeting, such person will need to ensure that a verbatim record includes the testimony and evidence upon which the appeal is based. - A. Ratify the retroactive use of piggyback contract to the date of February 1, 2021 with Brenntag Mid-South, Inc. utilizing terms and pricing of the City of Boynton bid 15-2821-19/IT for the supply of Sodium Hydroxide (Liquid Caustic Soda). This latest bid between Brenntag and the City of Boynton Beach for this chemical has just been renewed and will run from March 20, 2022 through March 19, 2023 at the cost of \$856/per dry ton delivered.
- B. Approve piggyback ITB #202119 with Pace Analytical Services, LLC, retroactive to December, 2021, utilizing the Village of Welllington's terms and pricing for laboratory testing and analytic services with initial term running until November 8, 2023, and with two (2) One (1) year renewals permitted pursuant to such Wellington bid.
- C. Approve purchase agreement with Tencarva Machinery Co. DBA Hudson Pump & Equipment for Gorman-Rupp products, parts, maintenance, and repair for an estimated amount of \$115,000.00. This is a sole source agreement for purchase pumps, parts, and repair for a backup to our master lift station and to guickly pump

down tanks for cleaning, maintenance, and repair. This pump will replace our previous Gorman-Rupp trash pump that we have had for over 30 years. This pump purchase also provides for single vendor maintenance and repair consistency with our smaller model Gorman-Rupp pumps.
